### **\*\* MOTORCYCLE SAFETY TIPS \*\***

**Protective Gear:** Always wear a properly fitted helmet. Over the ankle boots protect your feet and ankles, durable gloves provide a firm grip and protect your hands. Wear protective clothing like leather or durable materials that offer impact resistance and abrasion protection.

**Road Awareness: Assume you're invisible.** Understand that drivers may not see you, and constantly scan for potential hazards. Be aware of blind spots and avoid riding in them, especially larger vehicles. Use turn signals and brake lights to communicate your intentions.

**Defensive Riding:** Maintain a safe distance between yourself and the vehicles in front. Use the **Search-Evaluate-Execute (SEE)** strategy to assess and respond to hazards before reacting to an emergency. Look ahead and be prepared for unexpected maneuvers by other drivers.

**Motorcycle Maintenance:** Inspect your motorcycle before each ride including tire pressure, breaks, and lights.

**Additional Tips:** Avoid distractions, stay sober, don't take risks, and be visible.

## Karpouzi Salata Watermelon Salad

### Ingredients

- 1 watermelon, chilled and cut into bite-sized chunks
- 8 ounces feta cheese, crumbled
- ½ cup fresh mint leaves
- ¾ cup balsamic vinegar
- ¼ cup honey

### Instructions

1. For the balsamic reduction, add balsamic vinegar and honey to a small saucepan over medium heat and bring to a boil.
2. Reduce the heat and let simmer until the mixture reduces by half. Simmering should be about 12-15 minutes. Take off heat and let cool.
3. Cut the rind off the watermelon, and chop into 1" bite-sized chunks. Place into large bowl.
4. Combine crumbled feta and mint leaves into bowl and mix together.
5. Drizzle balsamic reduction over salad as needed and serve immediately.
