Arepitas de Yuca & Aranitas Cassava Fritters

Ingredients

½ pound yuca (cassava) 0.23 kg peeled and washed

- 1 teaspoon sugar (white granulated)
- ½ teaspoon salt
- 1 1/2 teaspoons of aniseed (anise seeds)
- 1 egg (medium)
- 1 ½ cup vegetable oil for frying
- 1. Grate the yuca with the fine side of the grater to make arepitas, or the course side to make aranitas. The steps are the same for both.
- 2. In a large bowl combine grated yuca, sugar, salt, egg and aniseed. Mix the batter until it is well combined.
- Heat oil over medium heat in a small skillet (oil should be at least 1 inch high. Add 2 tablespoons of the yuca mixture to the hot oil and fry until golden brown on one side, flip and repeat. Continue with the rest of the mixture and serve. Serves 12
